MINUTES

1. OPENING

a. Call to Order & Roll Call

Vice Mayor Rockett called the meeting to order at 6:06 p.m. Upon roll call, those present were Vice Mayor Jim Rockett, Council Member Tom Goltzené, and Council Member Ronald Jarriel. c. Approval of Agenda

Motion: Councilman Jarriel made a motion to approve the Agenda. The motion was seconded by Councilman Goltzené. The motion passed 3/0.

2. PUBLIC HEARING

a. Resolution No. 2012-14

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, RELATING TO THE PROVISION OF SOLID WASTE COLLECTION SERVICES IN THE TOWN OF LOXAHATCHEE GROVES, FLORIDA; APPROVING THE ASSESSMENT RATE FOR SOLID WASTE COLLECTION SERVICES FOR FISCAL YEAR 2012-2013; IMPOSING A SOLID WASTE COLLECTION ASSESSMENT AGAINST ASSESSED PROPERTY LOCATED WITHIN THE TOWN OF LOXAHATCHEE GROVES FOR THE FISCAL YEAR BEGINNING ON OCTOBER 1, 2012; APPROVING THE ASSESSMENT ROLL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

Acting Town Attorney Shana Bridgeman read Resolution No. 2012-14 by title, as printed above.

Town Manager Kutney referred to a proposal letter from Waste Pro dated September 10, 2012, and recommended that the Town take the proposal they provided.

Motion: Councilman Jarriel moved approval of Resolution No. 2012-14, with the reduced rate as proposed by the reduction presented by Waste Pro in their letter dated September 10, 2012, which is a reduction to the \$291.57 as printed in the Resolution attached to the Agenda, and authorize the Town Manager to make any calculations to arrive at that specific number. The motion was seconded by Councilman Goltzené.

Councilman Jarriel: Thank you to everyone for coming.

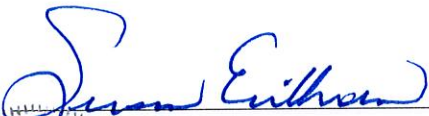
Councilman Goltzené: I like seeing the rates going in the right direction, and hopefully we can get it even lower. Thank you to everyone for coming.

Vice Mayor Rockett: Thank you to everyone for coming.

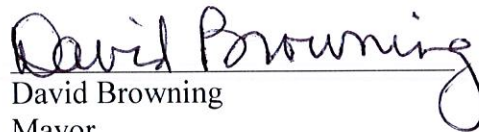
Town Manager Kutney expressed thanks to Councilman Goltzené for adjusting his schedule and attending this evening, as staff was working with a crucial timeframe.

4. ADJOURNMENT

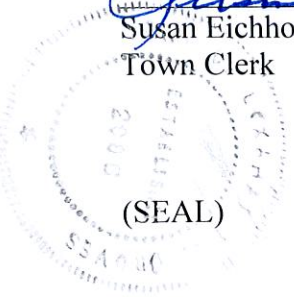
There being no further business, the Special Town Council Meeting held on September 13, 2012, was adjourned at 6:18 p.m.
